- 1. <u>Call to Order:</u> The Chairman called the meeting to order at 8:33 a.m.
- 2. <u>Roll Call:</u> A quorum was present.
- 3. Act on Minutes of 2/17/21:

MOTION: To approve the minutes of 2/17/21 (Sparkman, Grant). So voted unanimously.

4. Treasurer's Report:

MOTION: To approve the March Treasurer's Report (Sparkman, Grant). So voted unanimously.

- 5. <u>Communications:</u> The Executive Director noted the letter to OPM Secretary McCaw regarding the potential for regionalization in southeastern Connecticut and the testimony provided by SCCOG Chairman Allyn on the internet gaming bill.
- 6. Public Comment:

Ms. Jackman introduced T.J. Magnoli and announced two meetings that Eversource would be holding.

Representative Dubitsky informed the SCCOG about Raised Bill No. 1024 proposed by Desegregate CT.

Mr. Cwikla thanked Representative Dubitsky, and said he was concerned that RB 1024 could result in a loss of local autonomy.

7. <u>Guest Speakers:</u>

A) Dr. Roger Kuhns, CT Climate Lobby

Dr. Kuhns addressed the SCCOG on climate change and the need to address this global issue immediately. At the end of his presentation, he asked the SCCOG to consider a climate change resolution which he offered to draft and send to the SCCOG.

B) Donna Hamzy, CCM

Ms. Hamzy discussed the compromise language that CCM and Desegregate CT had agreed to and which is now included in RB 1024.

Representative Dubitsky raised several parts of this bill that he felt would negatively impact municipalities.

8. COVID-19 Response Discussion:

Mr. McCormack reported on the recent work of the Uncas Health District regarding vaccinations and other COVID-19 response actions.

- 1) DEMHS Region 4 Regional Recovery Steering Committee Update

The Executive Director said he had reported to the Executive Committee on the recent meetings of the Regional Recovery Steering Committee and the three working groups. He said that State funding for COG's work on COVID recovery has still not been identified.

The Deputy Director reported that the Project Steering Committee was meeting with the consultant tomorrow.

3) CMAQ Application Review

The Executive Director said that the Executive Committee had reviewed and recommended to CTDOT the Windham Regional Transit District's application for CMAQ funding to expand service, the only application received by the SCCOG.

MOTION: To submit to CTDOT the application by the WRTD as SCCOG's priority candidate for CMAQ funding (Urgo, Sparkman). So voted unanimously.

The Executive Director stated that staff was scheduling a meeting with CTDOT to meet with SCCOG members to discuss the Niantic Rail Station study and SLE improvements.
