4. COVID Long-Term Recovery Structure and Information Request re Potential Projects for Recovery Funding Applications

Ms. Cassandra Thomas, FEMA Federal Disaster Recovery Operations Officer, provided a briefing on the structure being followed by FEMA Region 1 and the State of Connecticut in addressing the impacts of the COVID-19 pandemic. Current efforts are focusing on matching needs with funding opportunities. FEMA is working with state agency staff and members of the State Recovery Steering Committee to develop recovery support strategies (essentially, "business plans" the State commits to working on). Ms. Thomas described the process by which FEMA and the State are soliciting project requests and working to match needs with available assistance (which could be funding or technical assistance). Project concepts are being solicited (due October 8th) and the Statewide Steering Committee will review them to prioritize further actions. Anyone can submit a project for potential assistance. The slide deck will be emailed to attendees.

5. Discussion of Future Steering Committee Meetings

The Committee discussed moving to a quarterly meeting schedule but was encouraged by FEMA staff to meet monthly in the near term. The Committee agreed to meet again in one month, with the tentative meeting date of October 28th (4th Thursday of the month).
