- 1) **Call To Order/Attendance** : Meeting called to order at 3:00 PM by First Selectman Pianka. Selectmen Ballinger and Tarasevich in attendance.

THE WORKING DRAFT PROPOSAL (**Attachment #1**) WAS PRESENTED BY FIRST SELECTMAN PIANKA FOR THIS BOS SPECIAL MEETING OF November 22, 2021 -----OVERWRITTEN ON THE MINUTES OF THE BOS SPECIAL MEETING OF SEPTEMBER 30, 2021 to assure that each item brought forth by the public at that time is being addressed.

After open discussion with all in attendance, the following recommendations were approved to bring forward for final approval at a TOWN MEETING to be held in early January (After the holidays):

NOTE: The top line for each item listed below (A through N) was the public proposal from the September 30, 2021 meeting, and the recommendations written below each item (italicized) are the result of this meeting (November 22, 2021).

- a) **Evelyn Brown**- Soccer Field facility at FMS (No cost estimate)
Recommend \$5,000 ARP allocation for Update Design Plan
- b) **Thomas Main Jr.**- Emergency Operations Center (EOC) \$30,000
Recommend second allotment allocation
- c) **Michael Smith**- Recreation Field at 59 Bozrah Street- 1) to protect playground with concrete barrier, 2) Update maps in the assessors' office (No cost estimates)
Recommend \$5,000 ARP allocation

- d) **Pamela Contino**- Senior Center-walkway and curbing trip hazards, entry door sticks (No cost estimate)
Recommend Senior Center Repairs budget line-No ARP funds

- e) **Ronald Leask**- Emergency Generator at the school (\$100,000)
Recommend Barber Electric proposal \$99,500

- f) **Scott Taylor**- Software system for Boards and Commissions interface (No cost estimate)
Recommend follow through with SCCOG- No ARP funds

- g) **Steve Seder**- Pavilion at Maples Farm Park (\$35,000-\$40,000)
Recommend \$15,000 ARP allocation

- h) **James Bonanno**- Completion of Route 82 waterline to the Montville town line. (\$1,200,000)
Recommend Infrastructure Grant Funding- No ARP funds

- i) **FD Chief's Requests:**
 - 1) Power stretcher \$30,000*
 - 2) Hydraulic Hurst tool \$13,000
 - 3) Structural Firefighter PPE (6 sets) \$30,000
 - 4) Cascade system (Fill oxygen bottles) \$65,000**Recommend \$95,000 ARP allocation*

- j) **BOS-Pianka:**
 - 1) TVCCA- \$3,000
 - 2) Uncas Health District- \$4,000*Recommend \$7,000 ARP allocation*

- k) **BOS-Ballinger:**
 - 1) Fuel tank replacement at the school
Recommend \$128,700 ARP allocation- (See presented cost detail sheets)

- l) **Raymond Barber-**
 - 1) Replacement of road signs
Recommend \$25,800 for signage replacement, Standardized signage upgrades and center line painting on South Road, Stockhouse Road and short curve sections of Bozrah Street Extension
 - 2) Riverwalk Park- walkway, erosion control improvements
Recommend No ARP allocation

m) **Website Upgrades**
Recommend \$19,000 ARP allocation

n) **Small business impact(s)**
Recommend No ARP allocation

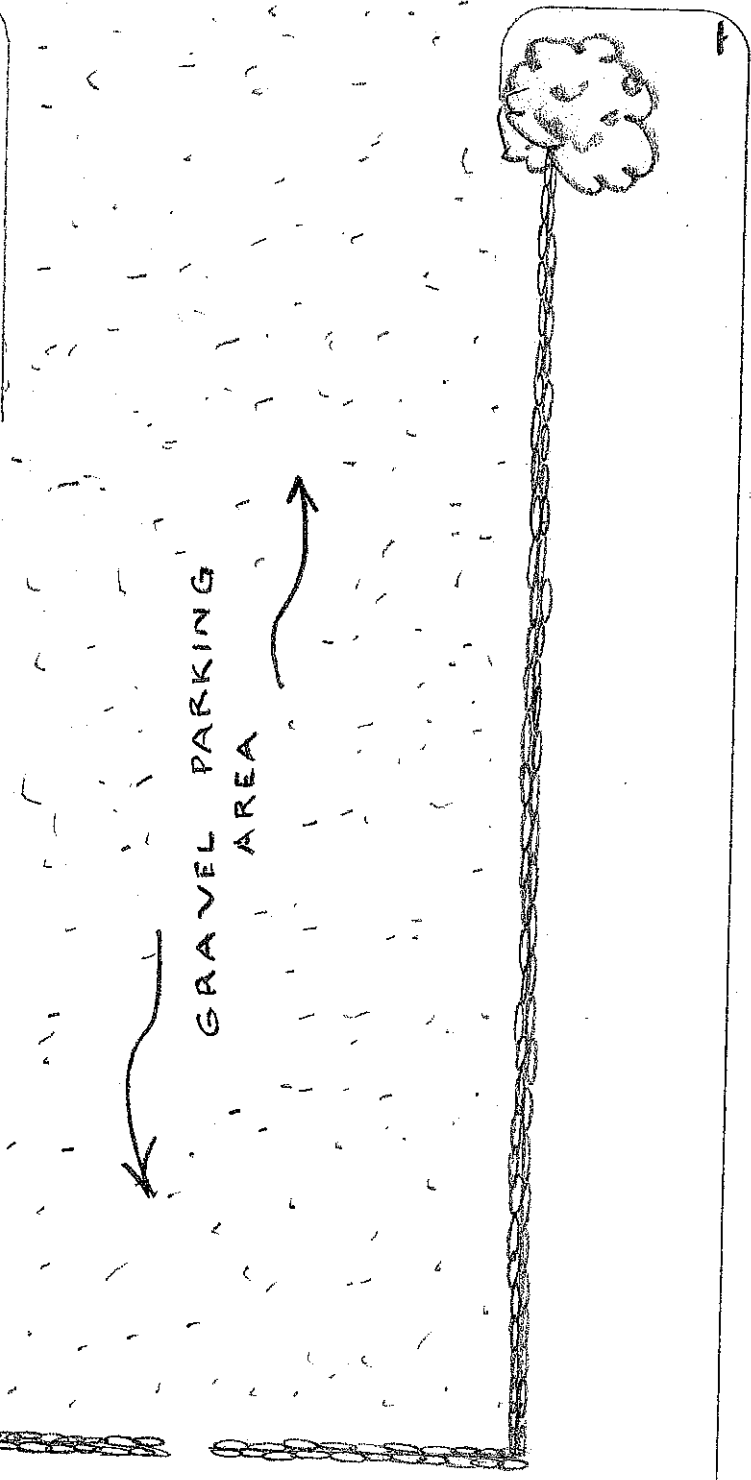
