#### **About the Position**

The Municipal Services Manager will play a central role in SCCOG's growing municipal services program, which currently consists of planning, building code enforcement, zoning enforcement, and support to planners and local commissions. The Municipal Service Manager will supervise and provide guidance to existing staff, manage contracts for services, and develop new programs as needed. This individual will also be responsible for staffing SCCOG's Regional Planning Commission and planner/commissioner training programs. The Municipal Services Manager shall staff one or more planner and/or ZEO contracts as needed.

## Qualifications

This is a Planner III level position requiring a bachelor's degree in planning, public administration, or a related field plus six years of experience or a master's with four years of experience. The successful candidate will have substantial experience working in a municipal environment and a strong understanding of land use planning and regulations governing land use and code

enforcement. Technical skills should include proficiencies in public speaking and written documents, and the ability to work in a team environment. AICP, CAZEO and/or Inlands Wetlands certification is desirable. Proficiency with ArcGIS, Excel, and InDesign is preferred. Candidates must pass a criminal background check for consideration.
