6. Workplan Activities

Ms. Haggerty provided an update on the lookbook. She is compiling resources to include in the document, and will begin reaching out to different groups and stakeholders for testimonials. The idea of this workplan is to help with implementation of affordable housing plans. The document will be a tool to commissioners and will be a tool to reach back out to commissions. Ms. Hurlbert suggested that there may be a Realtors Association grant available for work on the lookbook.

Mr. Allyn brought up the new required training for Land Use Commissioners. Ms. Kennedy said it could be used as a tool to train commissioners, since there is a mandatory 1 hour of affordable housing training. The board would like to work with SCCOG to develop affordable housing training that would satisfy this requirement for commissioners. The training could be held in October/November and SECHA board members could present the information.
